AMENDED ARTICLES OF INCORPORATION OF THE INSULAR LIFE ASSURANCE COMPANY, LTD.

KNOW ALL MEN BY THESE PRESENTS:

That we, a majority of whom are residents of the Philippine Islands, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the Philippine Islands,

AND WE HEREBY CERTIFY:

ARTICLE 1 - NAME

That the name of said corporation shall be THE INSULAR LIFE ASSURANCE COMPANY, LIMITED.

ARTICLE 2 - PURPOSES

That the purposes for which such corporation is formed are:

- 2.1 To carry on the business of Life Assurance in all its branches and in particular to grant or effect assurances of all kinds for payment of money by way of single payment or by several payments, or by way of immediate or deferred annuities upon the death of or upon the attaining a given age by any person or persons, or upon the birth or failure of issue or subject to or upon the happening of any contingency or event dependent upon human life or upon a fixed or certain date irrespective of any such event or contingency.
- 2.2 To grant annuities, immediate or deferred, payable between any fixed dates or contingent as to their commencement or determination upon any event dependent upon human life or the birth or failure of issue or otherwise.
- 2.3 To carry on the business of insurance against personal injuries by accident either in connection with life policies or otherwise.
- 2.4 To carry on the business of insurance against loss of health or incapacity from physical causes of any description either alone or in combination with life assurance.
- 2.5 To acquire or extinguish by purchase on surrender any policy or grant issued by the Company.
- 2.6 To create or set aside out of the capital or revenue of the Company a special fund or special funds, and to give to any class of its policyholders, annuitants or creditors any preferential right over any fund or funds so created, and for

such or any other purpose of the Company to place any portion of the Company's property in the name or names or within the control of ONE or more trustee or trustees, or to give to any class of insurers a right to participate in the profits of the Company or of any branch of its business.

- 2.7 To re-insure all or any of the risks of the Company and to undertake any authorized risk either by way of reinsurance.
- 2.8 To lend money on such terms as may seem expedient, subject to the requirements of law.
- 2.9 To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or company carrying on any business which this Company is authorized to carry on or possessed of property suitable for the purposes of this Company.
- 2.10 To promote any other Company for the purpose of acquiring all or any of the property and liabilities of this Company or of advancing directly or indirectly, the objects of interests thereof, and to take or otherwise acquire and hold shares in any such company and to guarantee the payment of any debentures or securities issued by any such company.
- 2.11 To take or otherwise acquire and hold shares in any other company having objects altogether or in part similar to those of this Company or carrying on any business capable of being conducted so as directly or indirectly to benefit this Company.
- 2.12 To enter into partnership or into any arrangement for sharing profits, union of interests, cooperation, joint adventure, reciprocal concession or otherwise, with any person or company carrying on or engaged in or about to carry out on or engage in any business or transaction which this Company is authorized to carry on, or any or transaction capable of being conducted so as directly or indirectly to benefit this Company, and to take or otherwise acquire shares and securities of any such company and to sell, hold, re-issue with or without guarantee or otherwise deal with the same.
- 2.13 To sell the undertaking of the Company or any part thereof for such consideration as the Company may think fit, and in particular for shares, debentures or securities of any other company having objects altogether or in part similar to those of this Company.
- 2.14 To amalgamate with any other company having objects altogether or in part similar to those of this Company.
- 2.15 To procure the Company to be registered or recognized in Hongkong, or in any other foreign country or state.
- 2.16 To remunerate any person or company for services rendered in placing or assisting to place any of the shares in the Company's capital or any debentures or other securities of the Company.
- 2.17 To distribute any of the property of the Company among the members in specie, but so that no distribution amounting to a reduction of capital be made without the sanction of law.
- 2.18 To make, accept, indorse and execute promissory notes, bills of exchange and other negotiable instruments.

- 2.19 To guarantee the performance of contracts by members of or persons having dealings with the Company.
- 2.20 To do all or any of the above things in any place in which the Company may determine and as principals, agents, contractors, trustees or otherwise, and by or through trustees, agents or otherwise and either alone or in conjunction with others.
- 2.21 To do all such other things as are incidental or conducive to the attainment of the above objects.
- 2.22 To do and perform and all of the acts and things and to exercise all of the general powers conferred by law upon corporations similarly organized and usually and ordinarily incidental to companies of like and kind.

ARTICLE 3 - PRINCIPAL OFFICE

That the place where the principal office of the Corporation is to be established or located is the City of Manila, Philippines, until 31 December 1962, and thereafter, is METRO MANILA. Starting 28 May 2014, the principal office of the Corporation is Level 30. Insular Life Corporate Centre, Insular Life Drive, Filinvest Corporate City, Alabang, Muntinlupa City, Metro Manila, Philippines. (As amended at the special stockholders' meeting held on 15 September 1986.)

(As amended at the Board of Trustees' and Members meetings held or 28 May 2014,

ARTICLE 4 - TERM

That the term for which said corporation is to exist is for another fifty (50) years from November 26, 2010.

(As amended at the Board of Trustees' and Members' meetings held on 22 July and 06 October 2010, respectively.)

ARTICLE 7** - CAPITAL

THAT THE CAPITAL OF THE SAID CORPORATION IS TWENTY FIVE MILLION PESOS (P25,000,000.00) AFTER THE CORPORATION HAD REACQUIRED, RETIRED AND CANCELLED ALL OUTSTANDING SHARES OF STOCK PURSUANT TO A PLAN OF MUTUALIZATION APPROVED BY THE BOARD ON 28 AUGUST 1976, BY THE STOCKHOLDERS ON 1 SEPTEMBER 1976, BY THE INSURANCE COMMISSIONER ON 1 DECEMBER 1976, AND BY THE POLICYHOLDERS ON 14 JANUARY 1977. THE CORPORATION IS NOW CONVERTED TO A NON STOCK MUTUAL LIFE INSURANCE CORPORATION FOR THE BENEFIT OF ITS POLICYHOLDERS PURSUANT TO SECTION 266, TITLE 17 OF THE INSURANCE CODE OF 1978.

ARTICLE 8 - SUBSCRIBED CAPITAL STOCK

That the amount of the said capital stock, in common shares, which has been actually subscribed is ONE MILLION ONE HUNDRED FORTY-EIGHT THOUSAND TWO HUNDRED SIXTY PESOS (P1, 148,260.00 Philippine Currency, and the following persons have subscribed for the
